## **CHAPTER 7**

### **TOWN OF FARMINGTON**

#### **CEMETERY ORDINANCE**

The Town Board of the Town of Farmington, Jefferson County, Wisconsin, does hereby ordain as follows:

##### **SECTION 1: TITLE/PURPOSE**

This ordinance is entitled the Town Of Farmington Cemetery Ordinance. The purpose of this ordinance is to control cemeteries located within the Town of Farmington, Jefferson County, Wisconsin.

##### **SECTION 2: AUTHORITY**

The Town Board of the Town of Farmington has the specific statutory authority, powers and duties, pursuant to § 157.50, Wisconsin Statutes, and/or its adoption of village powers under §60.10, Wisconsin Statutes, to acquire and convey by gift, purchase, or condemnation of land for cemeteries within or without the boundaries of the Town of Farmington and to determine, upon any acquisition, by ordinance, the system of management and operation of the cemetery, including appropriations for cemetery improvements.

##### **SECTION 3: ADOPTION OF ORDINANCE**

The Town Board of the Town of Farmington has, by adoption of this ordinance, confirmed the statutory authority, powers and duties noted in Chapters 60 and 157, Wisconsin Statutes, and has established, pursuant to these chapters and this ordinance those powers and duties of the Town Board of the Town of Farmington to manage and operate certain cemeteries located in the Town of Farmington.

##### **SECTION 4: MANAGEMENT AND OPERATIONS**

The Town Board of the Town of Farmington has, by this ordinance, established that the management and operation of the cemetery known as the Farmington Cemetery will be by the Town Board. Costs of maintaining the Cemetery shall be paid by the Town as deemed appropriate by the Town Board.

**RESOLUTION 1-2003**  
**CEMETERY BURIAL RATE**

WHEREAS, the Town of Farmington recommends to set a rate of \$250.00 per burial spot at the Town of Farmington and German Methodist Cemeteries; and

WHEREAS, in Chapter 7 of the Code of Ordinances let it be know a rate will be stated for burial site, in which both cemeteries have been currently updated and mapped out, the Town Board will record as such for the future; and

WHEREAS, the Town of Farmington desires to make a public declaration that the rate for one burial site will be \$250.00 for two burial sites will be \$500.00 and so on; and

NOW, THEREFORE BE IT RESOLVED, that the Town Board approves Resolution 1-2003.
