Dog Licenses:

According to Wisconsin State Statutes, all dogs **MUST** be licensed and have a **current** rabies shot.

Proof of immunization by a veterinarian must be presented to the treasurer at the time of obtaining a license. Dog licenses will not be issued without such proof. A new license is required for each dog every year by April 1st.
